Host reserves the right to re-instate a fuel supplement for all guests at up to \$9 per person per day if the NYMEX oil price exceeds \$70 per barrel. If Four Seasons Party Cruise receives notification of an increase in the fuel supplement rate, passengers booked at time of notification will be protected at the current fuel rate. Passengers booked after the effective date of a fuel supplement increase will be subjected to the incremental increase between the current and new fuel supplemental rate. Cruise rates are based on categories listed in US dollars, per person, based on double occupancy, capacity controlled and

subject to change at any time without prior notice. Government taxes and fees are additional for all guests.

A non-refundable and nontransferable deposit is required at the time of booking to secure confirmed accommodations. Special offers are valid for new bookings only and are not combinable with any other promotional offer. Special offers are capacity controlled and category restrictions and exclusions apply. No name changes are allowed after the final deadline date. A service fee up to \$50 may be assessed per stateroom for changes. Cancellation penalties apply. Restrictions and non-refundable deposit apply.

All prices that are listed are per person and include port charges. Airfare, pre/post cruise accommodations are not included. All cabins are based on double occupancy. Individuals seeking single occupancy will incur both the rate of two individuals in the cabin equating to 200% of the per person price, however single occupancy cabins will only be charged once for all taxes, fees and gratuities. Once onboard, tipping is not allowed.

Host reserves the right to affect a fuel surcharge if a rise in the market price of oil necessitates a supplement. There is no fuel surcharge currently in place. Taxes, fuel surcharges, port charges and all fees are subject to change.

Individuals under the age of 21 may have their own cabins provided they have a responsible adult guardian age 25 or older booked in close proximity on the same deck.

Currently, passports are HIGHLY RECOMMENDED to take this cruise. The US Government may require a passport and due to the nature of the itinerary. Without a passport, you will not be permitted to fly into or depart some of the islands by air if necessary, even in case of an emergency. Please take the time to view the travel link www.travel.state.gov to verify what documents are needed for travel.

Host reserves the right to change activities, events, performers, schedules at any time.

Note: Cabins may be sold out at time of booking. If both of your choices are unavailable, you will be notified of an alternative by email prior to your deposit being charged.

Payments

A non-refundable initial deposit of \$150.00 per person is due with your application. All prices are per-person based on double occupancy per cabin, unless otherwise noted. There are a limited number of triple and quad-occupancy cabins on the ship. For these cabins, the first two guests are each charged the full double-occupancy price. Additional guests in the same cabin are each charged \$100 less than the double-occupancy price.

Children under the age of twelve will be charged at the rate of half of the double occupancy rate. Proof of age must be submitted at time of booking in order to be booked at the discounted rate. Otherwise, regular rates will apply.

Roommate referral service is available upon request.

Deposit and Final Payment

A \$150 per person non-refundable deposit is required with your reservation to secure the cabin. The Final balance needs to be paid in full by August 31, 2011. Payments must be made in the form of a credit card, money order or cashier's check. No personal checks will be accepted after August 15, 2011.

Cancellation and Refunds

A non-refundable charge of 25% of the total cruise fare will apply for cancellation between the time of booking and April 30, 2011, booking changes will be \$25 during that time period. A non-refundable charge of 50% of the total cruise fare will apply for cancellation between the time of May 1, 2011 and June 30, 2011, booking changes will be \$25 during that time period. A non-refundable charge of 75% of the total cruise fare will apply for cancellation between July 1, 2011 and August 31, 2011, booking changes will be \$25 during that time period. A non-refundable charge of 100% of the total cruise fare

will apply for cancellation between September 1, 2011 and after, booking changes will be \$50 during that time period. After September 15, 2011 and after a non-refundable charge of 100% of the total cruise fare will apply for cancellation. **No booking** changes can be made after October 15, 2011.

Insurance

Immigration

U.S. and Canadian citizens must carry documentary proof of citizenship such as a passport or a certified birth certificate along with a photo I.D. A Social Security card is not acceptable as proof of citizenship. Aliens who are permanent residents must have their Alien registration Card and may need their passport. You are highly encouraged to visit the travel site www.travel.state.gov to confirm the required documents for travel. All other passengers should contact their respective embassies or U.S. Immigrations for applicable regulations. Boarding will be denied to those without proper documentation. There will be a \$25 or \$50 name change fee (ex: changing Sue to Susan; Bill to William, etc.) for any name changes made.
